




CRIMINAL RESPONSE TIME







Criminal – Electronic vs. Manual




MARYLAND APPLICANT OVERALL RESPONSE TIME



2015 FBI CHILD CARE CRIMINAL HITS












MARYLAND DISPOSITION RECOVERY EFFORTS OVER LAST 5 YEARS
